# Information on Advance Payment for Toyota City School Expense Assistance (School Enrollment Supplies) for 2026

Parents of new first year students at elementary and junior high schools in Toyota city enrolling in April, 2026 who submit their Financial Assistance Application by November 30, 2025 and meet the requirements for Financial Assistance can receive financial aid for school supplies before the start of school year.

## **Eligibility for Assistance**

- ① Family receiving Public Assistance (Note: New enrollment supplies are not covered. For enrollment preparation funds, please consult your public assistance caseworker.)
- 2 Family that had the Public Assistance benefit cancelled or annulled
- Those who are in financial trouble (Note: The total income of all household members, including those living separately but considered part of the same household (e.g., due to job relocation), must be within the standards set by Toyota City)

# Who can receive pre-entrance payment of school supplies for new students?

Those who meet all of the following requirements (1)  $\sim$  (4)

- (1) Those who meet the requirements for Financial Assistance for School Expenses (as described above)
- (2) Those who currently reside in Toyota city (excluding those who plan to move out of Toyota city before the entrance ceremony)
- (3) Guardians of students who are scheduled to enter a Toyota city elementary or junior high school in April of the following year
- (4) Those who wish to receive the pre-entrance payment of school supplies before entering the school.
  - XIf Applying After the Deadline (November 30, 2025)
  - If you apply for school expense assistance by the end of April 2026 and are approved in April, the new enrollment supplies assistance will be paid around July 2026.

[Note] If any of the following (A) through (C) applies to you, you are not eligible for the preentrance payment of school supplies for the new school year. Please do not apply.

- (A) If you move out of Toyota city before the entrance ceremony
- (B) If you are receiving public assistance.
- (C) If you have plans to change the family configuration (remarriage, etc.) before the entrance ceremony.
- \*If, after receiving the pre-entrance payment for new school supplies, a student no longer meets the requirements, the student will be asked to return the pre-entrance financial assistance of school supplies.

<sup>\*</sup>Income amount is the amount after deduction of employment income on the withholding tax form for salaried employees.

<sup>\*\*</sup>The total income of all household members, including those living separately but considered part of the same household.

<sup>\*\*</sup>The guideline for the amount of income will be revised in accordance with changes in the standard amount of public assistance.

## **Application Procedure**

Applications are accepted electronically via the Aichi Electronic Application System (Graffer).

If electronic application is difficult, paper applications are also accepted.

# (For Electronic Applications)

Scan the QR code on the right to access the application system.

 You may choose either "Register/Login to Apply" or "Apply via Email Without Account Registration"



- If you choose "Register or Log In to Apply," you'll be able to temporarily save your application during the process. Additionally, if your application is returned due to incomplete or incorrect documents, you can copy your previous submission (within 30 days) and resubmit it.
- Once you receive a confirmation email, your application is complete.
- You cannot modify your application after submission. Please enter information carefully.

- The electronic application system is compatible with translation features on devices such as smartphones and computers.
