If you have lost your certificate or it is incomplete, you may apply for a reissue at the counter (Citizens' Affairs Section, branch offices, or Ekiniishi Service Centre) or via online application. Please note that during main office closure times (Saturdays, Sundays, public holidays, and weekdays after 17:15), applications submitted at the Ekinishiguchi Service Centre will be accepted for processing only, and the certificate will be mailed at a later date.

Required items for counter application (From 14 October, 2025) No fee

Enclosed 'Application for Reissuance of Address Certificate Following Land Readjustment'Identification document (driving licence, My Number Card, Residence Card) – may be prior to change to new address

Required for online application (From 20 October, 2025)

My Number Card containing the electronic certificate for signature at the new address. Postage fee of ¥110 will be charged via electronic payment.

Other

Address certificates issued due to land readjustment will state the date of birth using the Japanese calendar.
